DECEMBER LUNCHEON SPEAKER, C. ROBERT JAMESON

Judge Jameson is the Presiding Judge for California's third largest court system: little ol' Orange County's unified courts. In this system, also the fourth largest in the country - Miami-Dade in Florida is larger - there are 109 commissioners, 1,600 employees, and a budget of \$165 million.

There have been changes in our county courts: Trial court funding is now administered by the State of California. Previously, the county supervisors were responsible for court budgets and court personnel. The Marshal function is now part of the Sheriff's responsibilities (a smooth transition in our case since Sheriff Corona was formerly Marshal Corona). And the Superior and Municipal courts are being combined into a single unified court system with some economies expected in the areas of payroll and personnel administration, computer systems, and applications of technology to our courts. The unification process is well under way.

According to Jameson, we can anticipate the streamlining of such functions as collecting traffic fines and some family law matters by ATM-like machines at local kiosks and e-filing on the web. He is also implementing a system of publishing the schedules of North, Harbor, Central, and South courts on the web, with calendars of cases to follow. Grand Jury recruiting continues to be one of Jameson's priority projects. He insists on getting as diverse a membership on the panels as possible.

TREASURER EXTRA-ORDINARY


The Board of Directors reviewed and adopted a budget for the association finances for 2001.

This may be Elsie Carruthers' last official act as treasurer as she turns the books over to our newly installed treasurer - Joe Quiros.

As in the past, our funds come expenses such as: the cost of this newletter which is mailed to members, legislators and departments in the county; and to host our speaker's meal at quarterly luncheons.

Historically, our funds have been used in various ways designed to raise awareness of the Grand Jury system and encourage recruits. The Board of Directors is explor-

ENERGY CRISIS

PAID ORIENTATION -INCREASED PER DIEM

The Board of Supervisors voted in January to pay incoming grand jurors \$25.00 per day during their orientation period, just prior to their swearing in.

They also voted to continue the part of the agenda item that asked for an increase from \$25.00 per day for sitting grand jurors to \$50.00. Sheldon Singer continutes to spearhead this campaign. Expect to see this item back on the Supervisors' agenda on March 6th.



FAMILY TASK FORCE

In a memo from Supervisor, Cynthia P. Coad to Dr. Michael Schumacher, County Executive Officer: "Action taken at the October 3, 2000 Board of Supervisors meeting directed the CEO to form the Foster Care Task Force, to be comprised of not more than 12 members. Supervisor Coad will assist in the selection of Task Force Members and will host the first meeting of the new Task Force in November.

In addition, Supervisor Coad asked as part of the motion, that the Task Force be called the Foster Children & Family Services Task Force and that it will meet to discuss and identify perceived gaps and needs relating to emancipation, adoption and foster care programs, as well as develop recommendations to address those gaps and needs with their first report due back to the Board in 180 days, and then every 6 months after that, until it's sunset in 2 years.


Supervisor Coad directed the Task Force to develop measurable outcomes and standards that can become indicators and triggers for change in the Continuum of Care for Orange County's foster children and families at-risk.

Supervisor Silva asked that the Task Force act as an action-oriented group, rather than a study group. Furthermore he asked that the group work on creating solutions rather than presenting the need again. Jim Palmer committed to the Board that the Task Force would focus on Prop 10 methodologies that would lead the County towards Outcome measurements for Children and Family Services.

Jim Palmer further outlined the direction to be given to the Task Force to the Board to include the following: development of pilot programs for the recruitment and retention of foster and adoptive parents; create and train a fully vested group of volunteers; provide a strong advocacy voice at the State and Federal levels; provide opportunities for community and faith based involvement; provide a venue for the formation of collaborations; solicit financial involvement from the private sector; strengthen partnerships among existing non-profit service providers; develop sources of less restrictive funding for innovative foster care programs; and develop strategic linkages to Prop 10 Commission.

The above action was unanimously approved 5/0."

GJAOC board member, Jim Nolan, has been selected to serve on this committee.
