"The Other Options re: El Toro Commercial Airport"

SEPTEMBER SPEAKER -BARRY NEWMAN

Attorney Barry Newman is a director of the California Grand Jurors Association, and is a former member of the San Diego Grand Jury. Newman told the GJAOC September luncheon audience of the controversial Kelso Report, currently under consideration by the California legislature, which would make some significant changes in the state's grand jury system. Among those changes:


- Take away the power to indict from the traditional ("Blue Ribbon") grand juries and provide for separate grand juries appointed from the petit jury pool to consider criminal indictments.
- Permit witnesses to have counsel during proceedings in grand jury chambers, if the investigation might result in an indictment.
- Provide for staggered terms for jury members.
- Establish a statewide training program for new panel members.

Newman pointed out several problems with these and other proposals.

DECEMBER SPEAKER -LEONARD KRANSER

Our speaker at the December 6 luncheon meeting will be Leonard Kranser, a retired businessman who now spends much of his time actively promoting an alternative use of the El Toro Marine base. Kranser is chairman of the El Toro Coalition, and website editor for wwwleltoroairport.org. We have heard from Jan Mittermeier, erstwhile county CEO, and general William Bloomer, executive director of the O.C. Regional Airport Authority, both of whom strongly favor the development of an airport at the former Marine Corps Air Station. We will now have exposure to the other side of this most contraversial issue. Make plans to join us.



Kelso, a professor at the McGeorge Law School, at University of the Pacific, submitted his proposed revisions having little familiarity with actual grand jury service. Newman said some proposals had merit but needed realistic fine tuning by people with experience in the trenches.

The training provision, in particular, came in for special attention by our speaker. Notwithstanding the difficulties in reconciling the widely differing needs of small and large California counties, it seemed quite self-serving, he said, for a law school professor to propose a rather ambitious (\$300,000 -\$500,000) "pilot project" presumably to be conducted by University of the Pacific.

HIP HIP HOORAY FOR SUPER GJAOC CONFERENCE

Once again, GJAOC is seen as a leader in California. This editor admits there may be some prejudice, but still maintains that Orange County knows how to get the job done well.

Jodie Harrod, Rose Moreno, Jim Nolan, Carol Morales and Joe Quiros did an outstanding job of arranging a first-rate conference in Costa Mesa - not once, but twice as many of you already know.

September 11th blew the original California conference date out of the water. Travel plans throughout the state were aborted, a new date was

chosen, speakers reappointed, attendees and hotel schedules were changed.

In their usual "can do" fashion, Jodie and her team pulled off a well attended, informative annual conference of CGJA. They were complimented and thanked over and over for the venues, the programs, the speakers, having a court reporter record the meetings, the food selections, etc.

The committee put together a notebook covering all aspects of the conference. This was presented to the President of the Marin County Grand Jurors Association for his use in planning next year's conference. The consensus of the CGJA Board members who saw the notebook, was that most of his work had been done for him by Harrod's hard working group.

A WORD OF CAUTION

The Board of Directors has been advised that certain individuals have been contacting members of the Orange County government and members of the Superior Court and representing themselves as speaking for the Grand Jurors Association of Orange County. Though sometimes this is true, many times these speakers are actually using our Association as a cover for the promotion of their own agenda.

At the November Board meeting the Board agreed, unanimously, that the Grand Jurors Association of Orange County would be represented by at least two members at business meetings that have prior board approval. This is consistent with the policy adopted by the Grand Jury concerning interviews and will insure that the Association positions are not inadvertantly misrepresented.

KELSO REPORT

The saga continues ...

Partly due to the delay of the California conference caused by 9/11, the deadline for comment to the Kelso report was continued to December 2001. Our Orange County Association has made comments to the study as reported in our last newsletter.

The State association will now be in a more solid position, following their conference, to give input gathered from statewide opinions.

Members of our board will be making contact with state legis-lators in the near future to raise awareness BEFORE legislation is written.
