A MESSAGE FROM THE PRESIDENT

To paraphrase Benjamin Franklin: Those who give up a little freedom in exchange for a little security deserve neither.

September eleventh is all too vivid to most of us, and is still in our minds. However, as current and former grand jurors, let us take a step back and observe what is happening now. It seems to me that there is definite but subtle erosion of our freedoms taking place in the name of security. Grand juries are very limited in their scope to examine government agencies within the county. I think we should



JUNE SPEAKER WILLIAM HABERMEHL

Mr. William Habermehl, Superintendent of Schools forthe Orange County Department of Education will be the Speaker at our June meeting.

Mr. Habermehl has worked in the education field for over thirty-four years with experience in teaching, coaching, site and district administration. He supervises over 2,900 full and part-time employees in the Orange County Department of Education who work with the local Orange County school districts.

Mr. Habermehl and his wife, Holly, have been Orange County residents for 37 years. They have three grown sons - all educated in Orange County public schools, and three grandchildren.



MARCH LUNCHEON SPEAKER Webster Guillory, O. C. Assessor

embers attending the March 7 meeting were treated to a grand tour of the County Assessor's office by its current occupant, Webster Guillory. Guillory used slides to give a thorough rundown on property values. There are 810,722 parcels of property on the Orange County tax rolls. That's a 74% increase over the last 26 years. And the assessed value of those parcels has increased by more than 780% in the same period to \$245.1 billion. Nearly 63% of those parcels are single family dwellings worth, in aggregate, \$152 billion. Average assessed values range from \$160,000 in Stanton to more than \$630,000 in Newport Beach.

Guillory's statistics show that in December last year the median home price in Orange County was \$332,000. Only five California counties have higher home prices and they are all in the Bay Area, with Marin County's median at \$542,500.

Our speaker discussed the subject of "equal protection" in a case where adjacent or similar parcels have different assessed values because the "base year" of one property puts it at a lower starting point than the other and real estate values have risen faster than Prop. 13 limits. So far, the courts have upheld the apparent inequity in these cases, but the controversy goes on. The "stay-putters," as he calls those who have remained in place and kept an early year as a basis for their assessed home valuation, have benefitted greatly from Prop. 13.

be aware of the encroachment of the State and Federal laws and orders being enacted which limit how our local County, State and Federal agencies act. I raise the issue as to whether grand juries in their reports should examine the affects of legislation on the ability of local agencies to act without impinging upon our liberties. Also brought to light in the same vein is legislation such as the Kelso Proposal and others, which would modify and restrict the freedom of grand juries to report and act. Grand juries do not exist in all states. But where they do, they should remain independent and act as ombudsmen for the citizen. The individual's voice can less be heard today than ever before. Our privacy and freedoms are being usurped by big government. Isn't it partly due to the failure of the Immigration and Naturalization Service and United States Customs to secure our borders that may have allowed this tragedy to occur in the first place? Now we have a Homeland Security bureaucracy rising from the ashes to do who knows what to our freedoms. Grand jurors – be vigilant – when examining our local agencies. Don't forget to look at the big picture to evaluate how State and Federal legislation is affecting the finances, freedom and ability of the local agencies to act in our behalf for our mutual betterment.


