

PRESIDENT'S MESSAGE



SEPTEMBER SPEAKER, GADDI VASQUEZ - PEACE CORPS DIRECTOR

"You've got the best job in Washington, D.C.": That's what his new colleagues in the federal government told Gaddi Vasquez last February when he was confirmed as Peace Corps Director. With roots in Orange County, Vasquez is a familiar face to many GJAOC members. He was 3rd District Supervisor in the late 1980s - early 1990s.

His new "best job" is a big job: Vasquez runs an agency with 7,000 volunteers working in 71 countries and with a budget of \$320 million. Begun in 1961 by President Kennedy, over its 41 years the Peace Corps has attracted 165,000 Americans to serve in 135 different countries as advisors at the grass roots level to improve the lives of millions of people and make friends for the United States. Gaddi cited several instances of how the seeds of good will planted years ago by volunteers, are bearing the fruit of goodwill today: In Afghanistan, a newly appointed minister-level official told Vasquez that Peace Corps volunteers who had taught her English also helped her form favorable opinions of America. And in Peru, the new president learned to like Americans as he practiced his English with volunteers.

The Peace Corps in not part of the State Department or any other cabinet agency: Vasquez reports to the president. He told of a "renaissance of voluntarism" which produced an increase of 42% in applications for volunteer appointments this year. There's plenty for new recruits to do: HIV/AIDS, which has become a disaster in Africa, is now running rampant in the Caribbean; A quarter of newborns in Afghanistan will not reach the age of 5; Population is growing at an alarming pace in a Third World which is not equipped to cope with it.

Want a job? Vasquez invited anyone to join him as a volunteer and take on "the toughest job you'll ever love."


CALIFORNIA GRAND JURORS' ASSOCIATION
