The Archivist

Jean Pasco, long time newspaper reporter for Orange County matters, will speak to us at our September 7 meeting. Jean left the LA *Times* in July to take a job with the Orange County Clerk-Recorders Office as Director of Orange County Archives.

A Cal State Fullerton graduate with a Political Science degree, she started her reporting career working part time for the LA *Times* while in college. After graduation, she spent a year with the Prescott (AZ) *Courier*, returned to Orange County to work at the San Clemente *Post Patriot* for a year, back to the LA *Times* for a year and then joined the OC *Register* from 1983-97. In 1997 she rejoined the Times until her taking her new job with the County in July 2006.

As a reporter, she covered many of the major events that happened in local and county government circles. She was a lead reporter for the *Register* during the 1994-95 County bankruptcy where she be-

came a familiar figure to many of us who served on the two 18-month Grand Juries at that time.

Familiar with most of the past and current government leaders, and with an extensive knowledge of how things happen or get done throughout the County, she has complete storehouse of topics to comment on. Jean resides in Costa Mesa with her veterinarian husband. She has a 17-year-old daughter and 15-year-old son who are in high school.


The principle speaker will be McGregor Scott, Federal District Attorney for Eastern California, who will compare and contrast Federal and State Grand Juries.

New 2006-2007 Orange County Grand Jury Selected

Santa Ana May 16, 2006 - The 19 members and 9 alternates of the 2006-2007 Orange County Grand Jury were selected today from a drawing held in Dept. C1 of the Central Justice Center, 700 Civic Center Drive West, Santa Ana.

The composition of the 19 members of the new Grand Jury include three Hispanics, one Filipino, one Asian, one African-American and 13 Caucasians; 14 males and 5 females. The average age of those This year, the GJAOC Committee selected is 66 years old, ranging from 47 to 82.

> Canvassing efforts for prospective Grand Jury members included the following: More than 3,000 applications were mailed to prospective applicants, and flyers were distributed to 1,190 companies and 111 minority organizations. Also, current members of the Grand Jury and the Grand Jury Recruitment/Selection Committee spoke to organizations and appeared on Spanish and Vietnamese language television and radio programs to inform the community of the opportunity to serve on the Grand Jury.

> Following a six-day training program, the members and three alternates will officially take the oath of office and begin their one-year term on July 3, 2006 at 10:00 a.m in Dept.




