SEPTEMBER LUNCHEON SPEAKER

September speaker Brett Sagel is an Assistant United States Attorney in the Central District of California in the Santa Ana Office, where he recently was the lead prosecutor in the corruption trial of ex-Sheriff Mike Carona. Sagel has been at this office since 2004 and with the United States Department of Justice since 1999. In the ten years of being a federal prosecutor, he has successfully prosecuted numerous jury trials and federal cases, including prosecuting and

convicting in a Capital Murder case involving members of the Aryan Brotherhood prison gang, the prosecution of tax cheat Igor Olenicoff, which resulted in a criminal conviction and a restitution payment of \$52 million to the federal government and other complex white-collar cases involving public corruption, corporate fraud, bank fraud, and tax fraud.

Be sure and come to hear his stories about big time Federal cases in and around Orange County.

BOARD OF DIRECTORS ELECTION

No additional candidates mailed in requests to be added to the list by the deadline of July 15, 2009. However, anyone wishing to be added or wishing to nominate candidates may do so at the September luncheon. In nominating any other member, please be sure that you have his/her permission to do so.

The election by mail involves the following:

- ballots will be mailed to all regular GJAOC members who are in good standing sometime after the September meeting;
- ballots must be returned by October 1st (envelopes will be provided);
- returned ballots will remain sealed until presented to the board at their October 8 meeting for tallying;
- results will be announced in the November newsletter and at the December meeting.

RESPONSE REVIEW

Your Board has set up a process where we can review responses to grand jury reports. Often, after a panel has been released, the required response is submitted. If it is determined that the response is not forthright, the county CEO would like to know. A Board member or a committee chair, will revisit the report and present comments to the CEO for further review or action. The agreement is to review reports within the last two outgoing grand juries in order to address somewhat familiar material but we have yet to receive a candidate report. We suggest that the foreperson of the jury, who is a GJAOC member, submit the reports for review.


CHARLOTTE CLEARY-BELL

SHELDON SINGER

Dr. Sheldon Singer (OC Grand Jury 1998-99) passed away in May 2009.

After WWII he returned to Ohio where he graduated from Ohio State University with B.S. and O.D. degrees. Moving to California in 1954, he opened his optometric practice in Garden Grove in 1956. He joined the Garden Grove Chamber of Commerce in 1957 and became president in 1965 and later started the Women's Division of the Chamber. In 1958, he was chair of the committee that proposed the Strawberry Festival to the Chamber. He then served on the Festival board for 15 years and was president in 1965.

Since 1959 Dr. Singer was involved, in leading positions, with the Boys and Girls Club, the Valencia Shrine Club, Kiwanis Club of Garden Grove, and the Flying Samaritans of Orange County in addition to his membership in the OC Grand Jury.

COURTHOUSE FEATURES

For those of you who have been behaving and/or have been off the court circuit for a while, some welcome features have been added to most of the court houses in the county.

There is a Self Help Office at West Justice Center, Central Court, and Lamoreaux Center. One-on-one help is available for filling out court documents and/or understanding court procedures. At West Court the Victims Assis-

tance Office is housed in the same tion, emergency assistance, restitution assistance, victim compensation, temporary restraining orders and other concerns of victims.

Now nearly all of the court houses have Children's Chambers which offer childcare services. Brightlycolored furnishings and toys invite children to spend time there while their parents attend court proceedings.

The Mediation Program at West Court which was initiated in 1999 continues to grow. Win-win mediation was introduced as an alternative to the win-lose solution in most trial cases. Mediation has resulted in a sizeable number of settlement agreements in contested cases. Members who are interested in becoming a mediator, please contact me.
