

less, personally satisfying and very rewarding. I look forward with anticipation for future opportunities to serve our Nation, State, County, and local communities.

I'm sure you are all aware that we are now in the recruitment period for the 2011-2012 Orange County Grand Jury. The Superior Court is currently sending notices to a long list of agencies and community organizations soliciting applications to serve. You have probably received an application package by now because former grand jurors are considered to be prime candidates. If you've ever considered a second, third, or fourth term, now would be an opportune time to submit an application. We have provided copies of a short recruiting video prepared by the 2005-2006 Grand Jury to courthouses around the county to share with petit jurors. Our own Lynn Bonas has given presentations to petit jurors at the Fullerton courthouse which adds a more personal touch to the recruitment video. I hope other members will find time to share their grand jury experiences with civic groups and meetings throughout our community. I solicited volunteers to serve on the GJAOC Speakers Bureau in an email message last month that went to members who have authorized us to correspond via that medium. I am very heartened by the overwhelming response. Lew Alvera, Carlos Olvera, Linda Rogers, Lynn Bonas, Howard Mirowitz, An Nguyen, Dianne Hoffman, Ann Andres, and Charlotte Fox volunteered to accept speaking invitations that may

arise. Such invitations aren't frequent but when they come up, it is comforting to know that there are members willing and able to serve as public speakers. Having a stable of speakers proved its value when the Fullerton courthouse asked us to send someone to speak to their petit juror pool about grand jury recruitment.

Speaking of recruitment, the California Grand Jurors Association has asked me to extend an invitation to all of you to consider joining the statewide organization. The CGJA is probably best known for their excellent training program for newly appointed grand jurors. In 2010, they provided training to 889 participants from 50 counties. The Association is also actively involved in Public Relations, Legislative Affairs, and Membership Relations. Dues are \$30 per year which entitles members to a copy of their quarterly newsletter and an opportunity to learn about grand jury activities in other counties across California. While membership in both a local and state Association might seem redundant, it is important to bear in mind that the statewide organization provides a service that is beyond our means. I would encourage you to consider supporting the important work performed by the CGJA. You can learn more about the organization by logging in to CGJA.org.

We will be losing some valuable Board talent at the end of the year when Carlos Olvera, Jerry Kranz, Rose Moreno, and Charlene Clark step down. They have all served with distinction and will be sorely missed. Rose Moreno has been our institutional memory and motivator for more years than most of us have been members...hopefully she won't relinquish ALL of her duties when she leaves the Board.

as his far ranging travels as a representative for the U.S. State Department. In 2010, according to his office, he continued work on jurisprudence projects with the governments of Armenia and the Republic of Georgia. In past years he has traveled to Brazil, Bosnia, China, the Philippines, Malawi and Mexico on similar projects.

He holds undergraduate and law degrees from UCLA. After serving as Marine Officer, earning a Silver Star and Purple Heart from combat in Viet Nam, he joined the OC District Attorney's Office. In 1981 he became a Municipal Court Judge on the OC Superior Court. He was an Advising Judge for the Grand Jury's reports and legal actions after the County's bankruptcy in 1994.

He was appointed to the Federal Bench in June 1998 by President Clinton and was confirmed by the Senate in October of that year. He presently sits on the U.S. District Court- Central District, Southern Division.

ORANGE COUNTY REPORTS SEASON'S FIRST INFLUENZA CASE

The Orange County Health Care Agency (HCA) has confirmed the first case of influenza signaling the coming influenza season. While flu season in Orange County usually peaks at the end of December or beginning of January, it is not unusual to begin seeing influenza cases reported early in the season and it is not too early to get vaccinated. The first reported case was Influenza Type A however it is not the pandemic 2009 (H1N1) strain of influenza.

Flu shots are anticipated to be widely available from private physicians, pharmacies and other retail businesses in the community. Information about these locations and dates is available at http://findaflushot.com. Beginning in October, flu shots will also be available for eligible individuals through the Health Care Agency's annual influenza vaccination program. The Centers for Disease Control and Prevention (CDC) has recommended that all persons 6 months of age and older be given flu shots every year and those in the highest priority groups should get their flu shots before the end of October. The highest priority groups include:

• Children 6-59 months of age • Pregnant women • People 50 years of age and older • People who are morbidly obese • Children and adolescents who are receiving long-term aspirin therapy • People with chronic diseases like heart disease, asthma, other lung disease or diabetes • People with a health condition that suppresses their immune or respiratory system • Residents of long-term care facilities that house people with chronic medical conditions • Household contacts and out-of-home caregivers of children 0 to 59 months of age • Health care workers.
