Board of Directors Meeting Minutes

January 8, 2015

Call to Order: President John Moohr called the meeting to order at 1005.

Absent: Virginia Zlakets. Past President Cheryl Brothers in attendance.

Minutes: Carol Duensing moved and Lynn Bonas 2nd that the November 6, 2014 minutes be approved. So approved.

Treasurer's Report: Bill Underwood passed out a two page handout detailing Revenues and Expenses. Bank balance is \$6,336.15 and the Certificate of Deposit Balance is \$8,987.84. New bank checking signatures with OCCU will take place at the 5 February 2015 meeting.

Membership: Carol Morales reported that the association has 99 paid members and 19 current grand jurors for a total membership of 118.

Programs: Joe Quiros proposed Larry Haynes and Karen Roper to be our speakers on the "homeless issue in Orange County" at the March 5th General Meeting. Menu options to be decided in February.

Newsletter: Bill to work with Cheryl on the current list of Associations members. Helen Alberts volunteered to run down missing e-mail addresses for Bill. The option of going paperless will be decided at next month's Bd. Mtg.

Correspondence: John brought up for discussion the e-mail sent by Fred Gebhardt to activate the Speakers' Bureau found in our By-Laws. This would require recruiting past grand jurors, identifying OC service organizations, preparing outlines/handouts, working with the current Grand Jury and the Court System. Fred to come back in February with a follow up proposal. John passed out Grand Jury recruiting flyers to the board to distribute in our neighbors etc. Deadline for applications is Friday the 23rd of January.
