Recap of the GJAOC's June 14 2018 Luncheon

Our June luncheon was well attended and MC'ed by President pro tempore Stan Ness. Our speakers highlighted what various OC cities are doing to address the homelessness crisis. Our featured speaker was Mr. Ken Domer, City Manager of the City of Fullerton. In addition, the Interim City Manager of Anaheim, Ms. Linda Andal and Stanton City Manager, Jim Box attended. We also had some researchers from Chapman University in attendance:

Mr. Kostas Kalaitzidis, Public Information Officer of the OC Superior Courts attended too. Mr. Kostas is Gwen Vieau's replacement and works with the Court and sitting Grand Jury to help recruit Grand Jurors.

Mr. Domer together with his Fullerton Housing & Neighborhood Services manager, Ms. Rebecca Leifkes gave us an overview of the current state of homelessness in the County, the City of Fullerton and the recent developments spurred by U.S. District Judge David Carter's demands with regards to OC homeless resources. In brief he mentioned:

OC spends \$894 million annually on all social services (incl. CalOptima, food stamps)

Approximately \$26 million are currently spent for homeless services. From the overall budget there is another approx \$55 million that can be spent on additional services directed at the homeless. OC's cities have been split into 3 Homeless Service Planning Areas (SPA). The idea is that addressing homelessness is best done on a regional/multi-city basis, and by combining resources, the homeless in all areas of the county will be better served. Additionally, those cities with limitations can leverage resources available within other cities in their particular SPA to the advantage of their local homeless (e.g. availability of low-priced land or facilities within a city's boarders). The SPAs and their current leaders:

- North Ken Domer (Fullerton)
- Central Scott Stiles (Garden Grove) & Jeff Parker (Tustin)
- South Dennis Wilberg (Mission Viejo) & John Pietig (Laguna Beach, and incoming President of the OC City Manager Association)

Mr. Domer also revealed that since Judge Carter instructed OC cities to identify and develop additional sites (defined and developed), within each city at which homeless services will be provided. For those cities unable to identify such sites, they will be required to commit real dollars to identified sites within their SPAs, to help share the burden of servicing the homeless. At this point, the identified sites are:

- Santa Ana Has identified a site for 700 beds (but will close the current 400 bed site at the Courtyard (former transportation center), for a nett gain of 300 beds.
- Anaheim an extra 325 beds at 3 locales for a nett total of 525 beds.
- Huntington Beach together with unincorporated Midway City will create an additional 75 beds across 2 new sites, for a nett total of 95 beds.

The speakers all emphasized the need for all OC cities and the county to work together to make meaningful progress on this issue; and underscrored the benefits accruing to all residents of OC, of helping the homeless get off of the street and to achieve self-sufficiency.

2017/18 OC Grand Jury Reports

The current OC Grand Jury finishes its term in 5 days, so we all know what that means: a flurry of activity to ensure their reports are finished on time. Until now, they have published 8 reports, all of which have received notice in the press. The reports thus far:

- Orange County Fire Authority Financial Flames on the Horizon? (03/20/18)
- Safer Schools What Can We Do? (05/03/18)
- Jail Food: Reservation Required (05/29/18)
- Where There's Will, There's a Way: Housing Orange County's Chronically Homeless (05/31/18)
- Orange County Landfills: Talking Trash (06/19/18)
- Can the Emergency Operations Center Survive a Catestrophic Event? (06/20/18)
- Competition or Collaboration Orange County's Public Agency Helicopters (06/22/18)
- Preventable Deaths in Orange County Jails (06/25/18)

This author took particular note of the first report which highlights the precarious financial situation that the OCFA finds itself in, as its majority financial contributor, the City of Irvine, considers leaving the group in a dispute over its required oversized annual payment. Equally timely is the report on housing for OC's chronically homeless population. The report makes a strong case for the county and all OC cities working together to establish Permanent Supportive Housing as a critical element to addressing the homelessness problem and reducing its physical and emotional toll on those experiencing homelessness, as well as the many costs it places on all OC governments (e.g. Crime, emergency room utilization).
