Grand Jurors' Association of Orange County Board of Directors' Meeting Minutes June 6. 2019

- 1. Call to Order The meeting was called to order by President Stan Ness at 1:40 pm. Roll Call: The minimum quorum of seven was established by the presence of the following members: Alf Lyle, Barton Harlan, Dave Chapel, Diana Merryman, Ian Guajardo, John Gallie, Lynn Bonus, Marie Whittington, Sandy Dunkin and Stan Ness. Members absent: April Lancaster and Joe Moreland. Also, in attendance General Member Bill Underwood.
- 2. Approval of Board Minutes of May 2, 2019.... Stan The President asked if there were any corrections to be made. There being none offered, Lynn moved that the minutes be approved as published, seconded and passed. Marie indicated by e-mail that the Continuity Committee had previously voted to change the name of the committee from "Tracking and Implementation" to The Continuity Committee. The Secretary noted receipt of that e-mail (see the Minutes of Feb 7, 2019 Item # 7 (E), 1. for verification of said name change.)
- **3.** Acknowledgement of Guests.... Stan (Note: No guests were in attendance.) This Board meeting followed the quarterly luncheon at the Phoenix Club. President Ness provided all Board members with an e-mail notice of the June 6, 2019 luncheon covering his proposed introductory remarks. (See Attachment #1.)
- 4. Treasurer's Report.... John Gallie (See Attachment #2.) It was reported that the Association Checking Account opening and closing balance was \$9,832.80. There was no checking account activity for this last reporting period. The six-month Certificate of Deposit had an opening balance of \$9,284.06, an earned interest deposit of \$12.13, and a closing balance of \$9,296.19. John reported that the current Credit Union rate for a six-month C.D. is 1.8% and 2.1% for a twelve-month C.D. Lynn Bonas moved that the Treasurer be authorized to renew the Association's C.D. for twelve months. The motion was seconded and passed by voice vote. The Treasurer offered a draft Budget for 2019. This item was discussed resulting in two amounts being increased from the original proposed amounts. Lynn Bonas moved that the proposed budget be accepted as modified. Motion was seconded and passed by voice vote. (See Attachment #3.)
- **5. Membership Report**.... Alf Lyle It was reported that a mixer for the incoming 2019-2020 Grand Jury panel, to be hosted by the GJAOC Board was being planned to take place in early July. Invitations will be sent to the new jurors inviting them to come to Dave Chapel's house during their lunch break. Volunteers will be needed to cover the set-up, food and drinks, name tags, etc.
 - (A) Post luncheon discussion (membership status).... Alf Lyle, Lynn Bonas (See Attachment #4.)
- 6. Programs.... Lynn Bonas -
- (A) Status of luncheon speaker for Sept. meeting Sheriff Don Barnes has previously been determined to be our first choice for September. Lynn will follow-up on this item.
 - **(B)** Suggestions for future speakers. Judge Nakamura will be contacted to see if he would be available for the December luncheon and swearing-in of the new Board of Directors.

Additionally, via e-mail, Marie Whittington suggested inviting new District Attorney Todd Spitzer to speak at a future luncheon.

7. Newsletter.... Mike Morris – (Mike was not in attendance and no report was given.)

8. Committee Reports:

- (A) Measure M.... Bill Underwood The "Belly-up" Report (per Mr. Underwood) Prior to this meeting Bill had e-mailed a copy of the OC Register article, dated June 1st, covering the screening of applicants for the Taxpayer Oversight Committee. The article also mentioned that Santa Ana and Stanton were out of compliance and will not receive Measure M2 (OC GO) funds for this year. Bill reported the following: 1) The GJAOC Measure M2 Committee completed its' work on May 24th. 2) Re: The proposed 2019 Budget for the Association, under "Expenses" Measure M, the amount was reduced from last years' \$2,000 to \$1,000 due to OCTA picking up much more of the reprographic costs. Therefore, the Association should net \$5,000 revenue. 3) There were 57 candidates that applied. The Committee reduced that down to 19. From those 19, the finalists will be selected by lottery, to represent each supervisorial district. The lottery will be conducted on Monday, June 24th at 9:00 AM at the OCTA headquarters. 4) Members from GJAOC gained an intern. 5) A new 5-year contract between OCTA and the GJAOC was signed. Bill will start reporting back to the Association Measure M2 activities next January/February. Thank you Bill and the committee members for all of your hard work.
 - (B) Speaker's Bureau.... Sandy Dunkin –

Each member was provided with a handout. (See Attachment #5.)

• Participation in Orange County Fair (statement below was submitted by Lynn Fenton):

"One of the things the Court used to do was participate in the Orange County Fair. In the Orange County building. - **(B)** Presentation of Proposed Standing Rules Bart and Dave Dave published a copy of the Standing Rules, (Subject to change at the discretion of the Board), dated June 6, 2019. This item is still lacking approval by the Board so that it can be presented to the General Membership pending a vote of final approval at the December 2019 luncheon meeting.
 - (C) Indemnification language for the Bylaws Stan and Dave (See Attachment #6.)

10. New Business:

- (A). GJAOC "Established Practices" (Dave Chapel)
 - 1. Standing Rules Revisions (Dave Chapel, Bart Harlan) (See statement above, 9. (B).)
- (B) Deciding on a "plan" for 2020 Goals and Objectives Dave Chapel Information will be sent out to Board members.
- **11. Adjournment:** The meeting was adjourned, without objection, by the President at 3:15 pm.

Subject: Liability

Stan said at a previous meeting that he would bring in some language IF, we wanted to add something about liability to our Bylaws. Here is what I have been able to find about liability for Non-Profits and the California Grand Jurors' Association:

This is general information. Specific situations should be discussed with an attorney or insurance agent.

INDEMNIFICATION STATEMENTS (no cost)

This is the organization's written expression of willingness to protect its board members and/or the Association by declaring a separation of a financial relationship. (Remember the old newspaper listing that said, "I am not responsible for any debts but my own.")

Sample language that protects the Board Member

The Board of Directors, shall not be personally liable for the debts, liabilities or other obligations of the Association.

Sample language that protects the Association

No Director shall have any authority to bind the Association to a contract or engagement or to pledge its credit or render it liable monetarily for any purpose or in any amount unless duly authorized by the Board.

LIABILITY INSURANCE POLICY (cost for the policy)

This covers damage to property or injury to people. The policy protects the Directors/Association if it is found liable for another's injury, illness, or damaged property. The policy also protects a nonprofit from claims brought against the Association due to volunteers' actions. There is a cost for this protection.
