We have the pleasure of the Honorable, Frederick P. Aguirre, joining us as our December luncheon speaker. Superior Court, Judge Aguirre has been a guest at many of our quarterly meetings and has been a friendly adviser to our organization for years. Along with administering the oath of office to the incoming 2014 board of directors, he will be speaking on the "Current State of the Orange County Superior Court". He will have a video message from the Chief Justice and will comment on next year's financial challenges posed by a reduction of the state allocated funds which will mean drastic changes in the way they conduct the court's business.

Myself, our treasurer- Bill Underwood and board member, Roy Baker attended the California Grand Jurors Association in San Luis Obispo this month. It always amazes me how different each county grand jury can be and how many similarities there are. We came away with intriguing ways to assist the courts on jury recruiting and screening of applicants. These efforts in other counties have saved the courts time and money, and contributes to a smoother, better selection of new panel members. The other hot topic was from chapters that are making the 'Implementation and Review' (IR) of previous year's reports work for them. We do have a system in Orange County that has worked the same in the late 90's, but the resent panels have taken on the task as one of their own by checking on implementation of the previous year's recommendations. Our board of directors will be discussing this more in depth in 2014.

You should have gotten a membership renewal letter in the mail recently. Reminder that you may pay your dues at the December check in table. Our thanks to Carol Duensing and Carol Morales for taking over this duty after the resignation of our membership chairman. We have managed again to keep the dues at the same rate of \$15 for 2014. This amount is intended to cover a few miscellaneous association expenses and the cost of your newsletter. Besides our current membership list of 150 members (on average), we mail the newsletters to all Orange County offices, department heads, all CA sitting grand juries, CA Grand Jurors Association board members, Panel selection judges, all city halls, and a few others who have expressed interest in the past – or about 400 pieces of mail in all.

#### FLU SHOTS IN OC

If you do not have a medical provider, or if you do not have health insurance coverage, you may obtain your flu shot free of charge from the Health Care Agency 17th Street Public Health Clinic, located at 1725 W. 17th Street, Santa Ana, 92706. Clinic start date and hours are listed below.

Start date: Thursday, November 7, 2013 and every Thursday thereafter through January 30, 2014.

Hours: 8:00 - 11:30 a.m. and 1:00 - 4 p.m. (closed 11:30 a.m. - 1 p.m.)

NOTE: Closed Thanksgiving, Thursday, November 28, 2013.

The flu shot is available for everyone ages 6 months and older.

The flu nasal spray (limited supply) is available for healthy people ages 2-49 years who are not pregnant and do not have certain health conditions.

You should delay getting a flu shot if you are sick or have a fever.

Walk-in Clinic—No appointment is needed.

Please wear a short sleeve shirt.

Mario Lazo, 1994/95 OCJG Foreman. passed away sometime in September 2013.

You may recall the 94-95 panel was confronted with the County's declaration of bankruptcy December 1994. #### IN MEMORIAM - LECIL SLABACK - 1976/77 PANEL

Slaback, Lecil Joel 1912-2013Lecil (Lee to friends) passed away the morning of Saturday, June 22, 2013 in Anaheim. . . . .

He followed in his father's footsteps, becoming an Official Court Reporter in 1936 for the Orange County Courts, serving for 36 years in that capacity. He was the first to use mechanical shorthand in Orange County.

While working as a court reporter Lecil also served on the City of Santa Ana Cultural Heritage Commission, served 2 terms as trustee on the Santa Ana Library Board, and was appointed by Governor Reagan to 2 terms on the California Consumer Affairs Board, representing the Board in investigations of court reporting schools throughout the State. Following retirement he was appointed by the Orange County Board of Supervisors to the newly created OC Historical Commission, serving for 21 years. At the Commission's first meeting it was voted to make the preservation of the Old Courthouse their number one project. He chaired the Commission's sub-committee to save the structure from the wrecking ball, turning it into a museum. He was a founding member of The Old Courthouse Museum Society. The Old Courthouse Library was recently named in his honor. Lecil was also proud to have worked on the Commission to save some 250 large, ancient live oak and sycamore trees in Irvine Park from being cut down to make way for road building. He served as master of ceremonies at the Commission's first placement of a monument commemorating historical sites, held at the old mining camp of Carbondale in Silverado Canyon. Lecil was a member of the Silverado-Modjeska General Plan Committee. The plan created the Foothill Corridor Advisory Committee, on which he served.

Lecil chaired the Justice Committee while serving as a member of the 1976-77 OC Grand Jury. At the same time he served on the OC Cable TV Advisory Committee. He was also a member of the OC Bicentennial Committee of the United States Constitution and the Committee to Commemorate the 100th Anniversary of the establishment of the County of Orange, contributing an article on court reporting to the time capsule buried in front of the Old Courthouse in 1989.

Lecil was interred next to his parents in Fairhaven Memorial Park on June 28. No services were held "pursuant to expressed wishes of the decedent."
