I supervised the Litigation Division of the office before being appointed County Counsel in 2001 and served until 2009."

A. STANDING Committees -

- 1. Program Committee, chaired by the 1st Vice President
- 2. Membership Committee, chaired by the 2nd Vice President
- 3. Nominating Committee
- 4. Audit Committee
- B. ACTIVE AD HOC Committees
- 5. Taxpayer Oversight Committee Selection Panel, for OCTA Measure M Series Bonds expenditures (1 vacancy exists)
- 6. Editorial/Public Relations Committee, which produces this quarterly newsletter
- 7. Legislative Committee, which focuses on legislation pertinent to the CA Grand Jury system
- C. CURRENTLY INACTIVE AD HOC Committees
- 8. Tracking & Implementation (TIC) Committee,

known in other CA counties as Implementation Review(IR) Committees to follow up on open responses to past GJ reports. The California GrandJury Association has recently issued IR guidelines, and the OC Board of Supervisors granted GJAOC review authority in 1994.

- 9. Public Service Committee, to report on County Boards, Commissions and Committees for potential openings for GJAOC members' service.
- 10. Speakers Bureau, to supply material/presentations for GJAOC members to give to organizations to build public awareness & encourage GJ recruitment.
