Contracts with Orange County Transportation Authority are negotiated every five (5) years.

*Editorial/Public Relations Committee*Produces the quarterly GJAOC Newsletter, conducts public relations for the Association and maintains the master mailing list.

*Tracking & Implementation – TIC:*Under the authority of the Board of Supervisors, reviews and reports to the CEO the implementation of those Grand Jury recommendations with which the subject organizations have concurred.

*Legislative Committee:*Reviews and reports on current and pending legislation pertinent to the grand jury system and recommends appropriate action.

*Public Service Committee*Reports on openings on County Boards, Commissions and Committees. Maintains a directory of these activities, plus terms of membership.

*Speakers Bureau:*Fulfills the objective of public education about the grand jury system. Members are supplied with grand jury information materials and give presentations to county clubs and organizations.
