Our very interesting December Luncheon Speaker -

Sheila Hanson

Orange County Superior Court Supervising Judge

Honorable Sheila Hanson was elected to the Orange County Superior Court in 2006. She was endorsed by the Association of Orange County Deputy Sheriffs; California Coalition of Law Enforcement Associations; and supported by over 50 Superior Court Judges

She was previously a Senior Deputy District Attorney, supervising the Felony Filing Unit. she had significant trial experience, handling 80 jury trials, many of them involving rapists, child molesters, sexual predators and criminal street gang members.

A strong believer in public service and community involvement, Hanson serves as a Board member for the Association of Orange County Deputy District Attorneys. In addition, she has served on the Board of Directors of Winifred Campbell Professional Auxiliary of Assistance League of Tustin and Laurel House youth shelter and is active in her church and children's schools.

After the Orange County Bar Association (OCBA) awarded Hanson its highest rating, '**Highly Qualified**' on May 25, 2006, for the position of Superior Court Judge, she was elected and became **only the second American of Iranian descent to be elected to the Superior Court of California.**

Hanson's father left Iran at age sixteen. He later became an American citizen and ran a successful small business in Orange County where Hanson was raised. In the early 1970's Hanson spent time with her grandfather in Tehran and Isfahan. She resided in North Tustin with her husband and two children.
