GRAND JURORS' ASSOCIATION OF ORANGE COUNTY

Board of Directors' Zoom Meeting Minutes June 3, 2021 @ 2:00 PM

- **1.** Call to Order The meeting was called to order by President *pro tem*, Lynn Bonas, at 2:06 pm.
- 2. Roll Call and determination of a Quorum Bart Harlan The Secretary (who was available by telephone only) took the roll with the following Board members being present on the Zoom call: Alf Lyle, April Lancaster, Barton Harlan, Diana Merryman, Ian Guajardo, Joe Moreland, Lynn Bonas, and Tim Ogata. Members absent were: Marie Whittington, Stan Ness. With eight (8) members present, a quorum was established. Also in attendance were Bill Underwood Chair of the Measure M / OC Go Committee, and John Moohr (Ex Officio Member). From the General Membership Sandy Dunkin and Teri Elders were also present on the Zoom call.

Notes/minutes from May 6, 2021, 2:00PM Zoom Bart Harlan – No changes were submitted to the Secretary. Mr. Moreland moved that the minutes be approved as posted, seconded, and approved with no further discussion.

- **3. Membership** Alf Lyle The 2nd V.P. felt that our luncheon on May 21st at the Phoenix Club was excellent. 47 people were in attendance, 11 of whom were from the current seated Grand Jury. It was noted that only one person turned in a contact form. Alf will get with Lynn Bonas to follow-up as to interest in our Association.
- 4. Treasurer Joe Moreland The Treasurer referenced his e-mail that he sent out to the Board and Committee members. "Attached is the May Budget Brief showing total assets of \$25,831.30 at the end of the month. The cost of lunch at the Phoenix Club has increased a bit and our \$20/lunch charge may need to be revisited. I checked on various options that the Credit Union offers for savings accounts and I suppose it is no surprise that interest rates on Money Market and Certificates of Deposit accounts have fallen dramatically. Even long-term (three-year) CD's pay less than 0.40 percent on deposits of less than \$25,000. We are currently receiving 0.70 percent on our CD which matures on July 2. Unless someone has thoughts on where we might want to stash our funds that would pay more generous rates, I think it is a waste of time to shuffle money around to earn a couple shillings a month. Additionally, I submitted our biennial Statement of Information (SI-100) form to the Secretary of State along with the \$20 filing fee today." (See Attachments #18.2)
- **5. Measure M / OC Go** Bill Underwood It was reported that the committee's work is done and that the Mission was Accomplished. The list of the 2021 finalists was submitted to OCTA. On June 28th at 9:00 am the OCTA Board will meet and hold a lottery to determine which of the finalists will fill the open positions. Mr. Underwood submitted an invoice to OCTA for \$6,000, which is the contracted amount for the GJAOC work in screening the applicants for the Taxpayer Oversight Committee (TOC). Bill suggested that our Association does not need to use \$1,000 (out of the \$6,000) to compensate a subcontractor in the

future but instead could use that amount to go towards a stipend for a proposed intern.

6. Old Business Lynn Bonas –

- A. Availability of the Credit Union for an In-Person meeting in August April Lancaster It was reported that it has been very difficult to communicate with the Credit Union. All of our contact people at the credit union, pre-Covid, are now gone. April got a contact name of a branch manager. A detailed message was left for this person. However, at this time, no answer has been received. April will keep working on this issue.
- B. Technology Volunteer Action Item/Discussion "Constant Contact"/ Newsletter /Facebook (currently private/ make it public?) Assisting with zoom, website update, assist Michael Morris Sandy Dunkin We received an application this morning from a member of the Current seated Grand Jury. This person appears to be very qualified. Sandy will send a copy of her application to the Board members. Any further consideration will be put on hold until after June 30th and the end of the term of office for the current Grand Jury. John Moohr commented that we do not want to become an "employer." Alf will arrange a Zoom meeting for this committee for further discussion and action.
- C. Externship. Judge Larsh's response. His Honor is supportive, but concerned about confidentiality. Ad hoc committee: April Lancaster, Tim Ogata, Birgit Sale, Lynn Bonas. Tim Ogata will be seeing or talking to Judge Larsh. The Judge wanted to know if there was a precedent regarding this issue. The Judge will submit our idea to legal council.
- D. Donations to non-profits. John Moohr would like to schedule a meeting for late June to discuss this matter. Lynn Bonas suggested that we consider donating some money to Marshal Moncrief's organization.

7. New Business (Action/Discussion) Lynn Bonas –

A. Wanda Shaffer resignation from the board. – Lynn indicated that she had received a Letter of Resignation from the Board of Directors from Wanda Shaffer. (See Attachment #3.) Lynn went on to report that Wanda and Sandy Dunkin had worked together on the Speakers Bureau. Sandy volunteered to be a nominee for the replacement on the Board until the end of the term and if there are no other nominations Sandy agrees to fill the position. • Lynn also reminded the Board that Diana Merryman needs to be replaced. Diana indicated her desire to not seek reelection to the Board back in December 2020. However, due to the Covid-19 restrictions the Association has not been able to conduct new elections as would normally be required by the Bylaws and the Calendar of Events. Diana has been very kind and patient and continued to attend Board meetings to help ensure that the requirement for a quorum be met. This matter will be an agenda item for the next Board meeting on August 5, 2021. • Lynn announced that our next General Membership luncheon will be on September 9th (the second Thursday) at the Phoenix Club. • There was no further New Business.

8. Adjournment: The meeting was adjourned by the President *pro tem* at 2:55 pm.

Note: By agreement there will be <u>no</u> meeting of the Board in July unless otherwise called.

The next scheduled meeting is for Thursday, August 5, 2021, at 10:00 am. Due to the unavailability of the OCCU conference room, we are tentatively scheduled to meet at Lynn Bonas' home (2345 N. Rockridge Cir. Orange, CA 92867). This will be confirmed when the August agenda is posted.
