Presidents Message

These are trying times to say the least. While all of our membership's priorities must remain with our personal and family health and well being, other aspects of our lives continue.

Hopefully, the following comments will enhance your understanding somewhat as to our Association's efforts.

After the recent luncheon of March 6, 2020, your board met briefly regarding Association business, adjourning with intentions to again meet at the next scheduled meeting on April 2, 2020. However, in light of recent public health concerns, the "in person" part of that meeting has been cancelled. However, your board continues to meet through e-mail and telephone conversations. Committee chairpersons are continuing to provide important information by reporting to the rest of the board in that manner. Your board continues to meet its obligations regarding treasury matters, committee efforts, and other association matters.

While we hope to have a regular board meeting in May, that decision along with other future meetings, including the June luncheon meeting will have to be decided by the board as circumstances permit.

We hope and pray for all our members and your families, and you can be certain that no steps will be taken which would in any way jeopardize the health of anyone.

As you may have heard, the application process for the 2020-2021 jury panel was struggling to obtain applications and the numbers of prospective candidates was at or near an all time low. Obviously, recruitment efforts by all interested parties have been less than fruitful. It is my personal opinion that this deficiency in applications is due to circumstances outside of our influence and in spite of our Association's substantial efforts.

Of considerable concern is the impact on the Grand Jury process by the current medical crisis, including the current panel, on the application process, and future panels as well. Hopefully, we will see significant improvement in the health issues before much longer.

That being said, the board has communicated with the Superior Court and the current Grand Jury panel offering them any assistance we are able to provide. Our membership has already been investigated, approved by the court, has relevant experience associated with prior jury service and continues to have a sense of community responsibility.

Should the court or the current Grand Jury reach out to us, or accept our offer of assistance, I would hope that we would stand at the ready and be available. Obviously, any and all efforts by us, or by others must be conducted with respect to medical considerations.

We have received a number of compliments regarding the March luncheon and the speaker and we would like to thank Chairperson Lynn Bonas for all of her efforts in that regard.

While our immediate efforts are subject to the serious set of present circumstances, we will prevail in the long term and we hope that every one of our members will be there to participate.

Most importantly, take care of yourself and your family.

PRESIDENTS MESSAGE

It's time for an update as to what is, and is not, happening within our organization. I am sure we are all a little tired of "prairie dogging", i.e. sticking our head up every once in a while to gauge current circumstances. Hopefully, you have all been careful and have jealously guarded your health and that of your loved ones. As well, we can begin to anticipate the return to some level of normalcy and stability.

Until that time, a short "state of the association" would seem to be in order. The board has not been conducting regular "in person" meetings for obvious reasons, however, most of the board members are in regular communication by telephone and e-mail. We are hopeful that we can begin regular board meetings in the near future and because of our limited number, should be able to practice social distancing. Such may not be the case with the quarterly luncheons where social distancing is a considerably greater issue. The board is acutely aware of the medically related challenges which are presented to those members who may be at a greater risk than others.

As a pandemic consequence, our recruitment efforts for Grand Jury applications have been greatly reduced and limited to the distribution of some written materials. Our association's financial condition remains quite constant, all things considered, and the financials are reported in our minutes, which along with other information can be found on our website.

Our Measure M committee, capably chaired by Bill Underwood, has continued to conduct the process for the selection of the OCTA oversight review members. This very important function is a feather in our hat, generates a few dollars in our budget, and most importantly is an example of what our organization is capable of accomplishing. Many kudos to Bill and the members of his committee for their extraordinary efforts.

As you can imagine, the Covid 19 restrictions have had a very significant effect on the present sitting Grand Jury panel and I am sure we will learn more about what they have had to endure as time passes. Equally problematic are the circumstances the Superior Court has been faced with including the increased difficulty associated with the selection process and the impaneling of the new 2020-2021 jury panel.

But there is some significant and welcome news in that regard. Judge Larsh has empowered a group of folks, along with court support staff to organize and arrange a more extensive orientation of the incoming panel. To that end they have been able to arrange funding for the

state training program and have contacted Foreperson Birgit Sale (2018-2019), who is now a member of the California Grand Jury Association's training program. The state association's training program is of high quality and very all encompassing and will be presented to the new grand jury panel during a two day session in late June.

In addition, the organizing group has also recommended a third day of training which is to concentrate on those matters particular to Orange County including the day to day mechanics of how the local panel works. While the state program will cover the vast majority of training, our association through some of its members will participate in the local aspect of the training.

Over the years, many members of our association have expressed the need for improvement in the training of incoming panels. Almost to a person, we have had the feeling of indecision that comes with the unfamiliarity of beginning a new endeavor. How many times have we heard the phrases "How do we do that?", or "Can we do that?". How much time and effort has been lost until we found our way?

I could not be more excited to see this development and appreciate the court's willingness to find the funding for such an important issue. It reflects an understanding on the court's part as to the importance of the Grand Jury. I suspect there will be many practical and organizational issues facing the incoming panel in light of the restrictions which have become the new norm. Now is the time to support them, the courts, and our other public entities as much as we possibly can. The court has obviously taken a giant step forward for the Grand Jury process and it is up to us to support this effort.

While the GJAOC will be able to return to normalcy at some future date, we must do so safely and we are doing our best in that regard and hope to inform you of those developments as we proceed. And, please do not be shy in letting the courts know of our appreciation of their recent support. As always, please contact myself, or any other board member with any questions you might have.
