Since these presentations started in October, over 450 fliers have been passed out, and as of the first full week in December there are 46 applications.

I have asked Association members to be ready to take on more challenges, and I just received word that the Court Ambassador program is being restarted. This group will receive training and be responsible for leading tours of the Central Justice Center for groups of students from local schools. This is an opportunity to teach these young people about the importance of the courts and how they have a stake in serving their community. More details will be coming soon, and I know that there are several members who have already expressed interest in working with the Court on this project.

As citizens of Orange County who have contributed in a very unique manner by serving on the Grand Jury, we have a duty to bring this wonderful opportunity to those who have no knowledge of what can be achieved by those who reside here. Major changes have been made in the County through the recommendations and reports of past Grand Juries. Department performance has been improved, those in leadership have been held accountable, and the media has followed up on past reports to ensure that those in leadership are listening.



The Association was introduced to the incoming Assistant Presiding Judge, Cheri Pham. Judge Pham has a distinguished background having served as a Public Defender and Assistant District Attorney, after graduating from Edison High as Valedictorian, Summa Cum Laude from UCLA for her BA, and earned her law degree from Boalt Hall. She will be supervising the Grand Jury in 2023.



Judge Carter spoke about the Homeless and how we no longer have major encampments in Orange County. He reported that the model of 60 plus one has enabled the county to provide shelter beds, not permanent housing, for Orange County's homeless population. He complimented cities in North Orange County for working together on solutions. South County is lacking in shelters and must step up. Judge Carter has other cities & counties in his courtroom currently, including cities in Los Angeles, Ventura and Santa Barbara counties. He emphasized that local politicians need to ensure public funding is expeditiously put to use and monitored closely.
