#### OC Go / Taxpayer Oversight Committee Screening Panel

The five member GJAOC OC Go 2023 TOC Applicant Screening Panel has successfully completed their work this year. In May, we

presented ten Measure M Taxpayer Oversight Committee (TOC) independently screened finalists to fill the two openings on this 11-person staggered term committee, chaired by the OC Auditor Controller.

At the June 26, 2023 OCTA Board Meeting, two names were drawn by the Chair of the Board in a blind draw to serve 3-year TOC terms. The check was delivered to the GJAOC for services rendered in record time this July. A 3-person GJAOC sub-committee is now working with the OCTA for the next 5-year contract to continue our three decade streak mandated by Measure M to achieve taxpayer trust.
