Apply for the May 2024 GJAOC Screening Panel of Applicants for the OC Go/Measure M Taxpayer Oversight Committee (TOC).

This is an opportunity to engage with interesting & capable OC residents, provide a public service for OC taxpayers, supplement revenue for the GJAOC and even receive meeting stipends for your time, skills and expertise.

The GJAOC Screening Panel is made up of GJAOC volunteers, as mandated by voter approved Measure M/M2 to be independent of the OCTA and elected officials. We screen candidates, interview applicants and recommend multiple candidates for an OCTA Board blind lottery for TOC openings by district.

The GJAOC panel does all its work within the first 2 weeks of May and has standbys to provide staffing flexibility. So a limited commitment of time for such an important key role to ensure fiscal responsibility for such large OC transportation expenditures. "Steiner's Way" Street Named for William Steiner Bill Steiner's recognition by the Board of Supervisors is well deserved and earned after serving Orange County as a voice for generations of abused, neglected, abandoned, and vulnerable children. Bill passed away in 2022 at the age of 85. The street is in Orange, where he once served on the school board and City Council before becoming a Orange County Supervisor.

Several years ago, Bill spoke at a GJAOC luncheon where he praised the Grand Jury report that helped forge Albert Sitton home into Orangewood Children's Home. He gave a great deal of credit to the Grand Jury for investigating and reporting on the conditions, especially the overcrowding issue, that led to expanded facilities and staffing through the county and community joining forces to protect the most vulnerable citizens in Orange County.

And he did it "Steiner's Way", which is the name of the street named after one of the most altruistic and kind men who spent his life committed to public service and as an advocate for children.
