Recognition Committee Update

This year the GJAOC will recognize and honor two organizations that diligently address issues of interest to previous Grand Juries: protection of our environments and dedication to animals in Orange County.

Kevin Marlin, Executive Director of OC Animal Allies, will deliver one of the presentations at the September 12, 2024 general membership luncheon. OC Animal Allies began in 1984 as a small group of resolute animal lovers in Orange County dedicated to helping Orange County residents and their animals. It is an independent, volunteer-driven, non-profit and is not affiliated with any other SPCA, including the ASPCA.

Darin Loughrey, Outreach and Engagement Coordinator of Natural Communities, will also deliver a presentation at the September 12, 2024 luncheon. The Natural Communities Coalition (NCC) was established in 1996 as one of the first steps following the signing of a landscape-scale habitat planning and conservation efforts for wildlife and their critical habitats. It initially was know as the Nature Reserve of Orange County.



GJAOC Measure M/OC GO TOC Applicant Screening Panel OPPORTUNITY

The 2024 GJAOC Applicant Screening Panel is underway! The public is responding to ads & notices for 2024 applicants to serve OC. Measure M/OC GO is providing 4 folks the opportunity this year to join 6 other folks on the Measure M/OC GO TAXPAYER OVERSIGHT COMMITTEE (TOC)! There are 10 TOC members (2 per 5 districts) chaired by the voter elected OC Auditor/Controller. The public TOC application deadline for Districts 1, 2, 4 & 5 is May 3rd, 2024.

The TOC is a public watchdog committee, independent of the OCTA and Elected Officials, charged with ensuring that the OCTA & OC

Cities spend Measure M sales tax funds in accordance with the voters' mandate of Measure M. The long-range OC transportation plan details billions of \$ planned for transportation investments.

The GJAOC TOC Applicant Screening Panel role is to independently annually screen and interview TOC applicants. It is a very stimulating interview experience. The Panel recommends 3-5 candidates for each of the 5 OC Supervisor districts that have a TOC opening that year. Those candidates are put into a public blind lottery by district at an OCTA Board meeting in June. Each candidate selected in the lottery begins their 3 year term in July at quarterly TOC evening meetings.

The 2024 GJAOC Applicant Screening Panel will perform their Panel work this year primarily in the first full two weeks of May! The panel consists of: Bill Underwood (2011-12) & Virginia Zlaket (2012-13) with multiple years on the Panel; Lynette Fujitani (2021-22) & Patricia LaVoie (2020-21) who served last year; and Lynn Fenton (2017-18) & Peter Hersh (2015-16 Foreman) are new this year.

The newly formed GJAOC Panel Advisory Group was formed with experienced former Panel members with a decade of experience to provide GJAOC panel institutional knowledge continuity & negotiated the 5 year contract renewal. They are Robin Bowen (2009-10), John Moohr (2009-10) and Bill Underwood (2011-12).


Volunteers
